## **Preparing Your Paper**

## **Article Type: Original Paper**

- Should be written with the following elements in the following order: title page; abstract; keywords; main text introduction, materials and methods, results, discussion; acknowledgements; declaration of interest statement; references; appendices (as appropriate); table(s) with caption(s) (on individual pages); figures; figure captions (as a list)
- Should be no more than 6000 words, inclusive of:

- Abstract
- Tables
- References
- Figure or table captions
- Should contain an unstructured abstract of 200 words.
- Style Guidelines
- Please consistently use the British (-ise) spelling style throughout your manuscript.
- Please use single quotation marks, except where 'a quotation is "within" a quotation'.
- Please note that long quotations should be indented without quotation marks.
- Please note that using footnotes is discouraged; all essential information must be included in the article's main body of the text.
- All Contemporary Dialogue submissions should be in English and submitted in Microsoft Word. However, Tables and figures should be embedded within the text rather than at the end of the document.
- All manuscripts must be double-spaced and must adhere to the guidelines published in the Publication Manual of the American Psychological Association (7th edition).
